

## **WASHINGTON TOWNSHIP SENIOR TRANSPORTATION SERVICE**

- Service is curb to curb and limited to Washington Township residents age 55 and up.
- Transportation is available for medical appointments in Long Valley, Hackettstown and Chester. Appointments must be scheduled between 9:30 a.m. and 1:00 p.m.. Please call for more information regarding these appointments.
- Grocery shopping is available once a week to either the Chester or Mansfield Shop Rite depending on where you live.
- Transportation is also available for Senior Citizen meetings held by the Chester Fifty Plus or Golden Age group of Long Valley.
- Residents are required to read and complete the Rules and Regulations, an Emergency Information Form and a Hold Harmless Agreement to ensure safe passage for all riders.
- Transportation is not available on Holidays weekends or during inclement weather.
- Please keep in mind the earlier you call to reserve transportation the easier it is to meet your request.
