They also discussed whether to make the ordinance applicable to dumpsters smaller than 30 cubic yards. The consensus was to not amend the ordinance for the time being, while other enforcement efforts are being pursued.

With respect to IT/shared services, <u>Mayor Short</u> expressed the Committee's desire for the Township to pursue financial efficiencies through shared services. All municipal departments have been reviewed. Recently, IT has been the focus. One of the IT positions will be eliminated at a significant cost savings to the municipality. The Committee discussed that the elimination of the position does not have anything to do with performance. The Township Committee decided that Robert Kelly's position will be eliminated with the cost savings to the Township as the predominant factor in this decision. Mr. Kelly's position will be eliminated effective August 1, 2012.

<u>Mr. Kelly</u> made a statement that he has been employed in public service for almost 40 years. He has served the Township to the best of his abilities. He has the utmost regard for the people of the Township; however, he is saddened by this outcome. He stated he did not wish to remain until Aug. 1 nor assist the designer of the new website.

Formal action on the elimination of Mr. Kelly's position was deferred to Monday's Regular meeting. Mr. Kelly will be Riced again for that meeting.

FAIRVIEW AVE INTERSECTION - **Comm. Kennedy** stated, in response to inquiries, that paving of a portion of Fairview was provided for in the budget and that was what the road department paved.
