APPLICATIONS/PUBLIC HEARING:

Toll NJ II LP, Soil Disturbance Permit on or near an existing detention pond on the property known as Block 18 Lot 8.11. R5 Zone [The Black Oak Golf Club]. Time is 7:29 PM

Present for the Applicant is Michael Selvaggi, Esq. In addition, Mark Mayhew, PE and SVP, Managing Director from ESE Consultants, Horsham, Pa. who prepared the Application and plans. Mr. Mayhew was sworn and accepted as a witness.

Mr. Selvaggi reported that this application is to allow earth work on or near an existing detention pond on this property which is part of the Black Oak Golf Course. The current basin is no longer holding water and it has been recommended to convert this wet basin to a dry basin.

Mr. Mayhew then proceeded to mark aerial photo of site with Pond 2 in caption as Exhibit A1. This site currently has six ponds and it has been recommended to eliminate this pond in fear of water infiltration in lime stone formation. Mr. Mayhew then defined the difference between a wet and a dry detention pond.

Next Pond 2 Remediation Plan View Rendering dated November 15, 2017 was marked as Exhibit A2. This rendering shows a Bentonite path on the pond bottom. The proposed changes will not change the direction of out flow, it will continue to flow as it was designed.

What triggered this Application is the amount of soil being moved from the Regency at Flanders New Jersey Toll Brothers location to this site. 1,000 cubic feet of Fill and 500 cubic feet of Top Soil will be relocated. Per Township Ordinances soils have been tested and accepted by Township Officials.

Mr. Meyhew reported that Morris County Soil Conservation has Certified and approved project and the work should commence in April.

Mr. Selvaggi while referring to Board Engineer Hall's June 28, 2017 letter had Mr. Meyhew answer each of the three points noted in the closing paragraphs. Mr. Selvaggi marked as Exhibit A3 Dr. Keller's email to Mr. Mayhew noting Dr. Keller's approval. However, it was agreed that Ms. Lyons will contact Dr. Keller for letter to file. If the letter is not received in time for Township Committee consideration it will be a condition to the Resolution.

Regarding point # 2 in Mr Hall's letter Mr. Selvaggi marked the July 6, 2017 letter from Robert Brightly, PE from Ferriero Engineering to Mr. Mayhew.

In closing Mr. Meyhew noted that the only other government entity to review is Morris County Soil, which has approved the Permit and therefore the Applicant has satisfied the standards for the Soil Permit.

Questions/comments for Witness:

Mr. Norton – No additional comments. Sufficient soil testing was performed and is satisfactory.

Mr Leavens- Why not line the entire pond with Bentonite. Mr. Mayhew answered it was agreed to take a conservative approach.

Committeeman Forsbrey – What prompted this Application? Mr Mayhew noted that the Estates at Long Valley housing project is ready to close out. The concerns regarding the pond first needed to be addressed before the housing project can close out.

Time is 7:55 PM – No Public Comments regarding this Application.

- 1- Ms. Lyons to secure a letter from Environmental Consultant Dr. Jeff Keller that the environmental landscaping aspect of the application are approved.
- 2- Applicant shall line pond with Bentonite the cross-hatched area as shown on Exhibit A-2 to the satisfaction of Dr. Oweis and the Township Engineer.
- 3- Final approval from the Township Engineer of the revisions recommended by him
