NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Washington, that the Township of Washington hereby endorses the submission of a Municipal Recycling Tonnage Grant Application to the New Jersey Department of Environmental Protection, Office of Recycling and designates: Roger Read, Assistant Superintendent of Department of Public Works 54 Rock Road Long Valley, New Jersey 07853 to ensure that the said application is properly filed.
