PLEDGE OF ALLEGIANCE. The Pledge of Allegiance was recited.

RESOLUTION DISCUSSION

DISCUSSION

Request to Remove Deed Restriction, Block 56, Lot 26.05. Property owner Eric Jania was present to answer questions regarding his request to remove a deed restriction. He would like to construct a single family home on his property for his in-laws. The Planning Board and Board of Health have approved the request. The Committee agreed and will consider an Ordinance at the May 18, 2015 Regular Meeting. Administrator Coppola noted that there is a shortage in the escrow account which needs to be satisfied prior to the adoption of the Ordinance.

<u>Hunting Bids.</u> The Committee discussed the upcoming bid process and decided to add a minimum bid price to the invitation for bids.

Eagle Scout Ceremony Attendance. Mayor Roehrich will attend the upcoming ceremony for Connor Onweller.

Heath Village Zoning Change. Vice Mayor Short offered several comments including: adding language to the Ordinance that states Heath Village will provide senior transportation; that the roads within Heath Village will be maintained by Heath Village; that COAH units should be dispersed through the community and not be constructed in one location; that the 25' setback mentioned in paragraph D6 be confirmed to be adequate to accommodate driveway parking that will not encroach on the sidewalks, and that paragraph E4 be examined to insure that ample parking is available for employees and visitors.

Committee Members agreed and <u>Administrator Coppola</u> will inform Planner Banisch of these comments and suggestions.

Temporary Part Time Recycling Laborer. The Committee will fill this potion at the Regular Meeting.

<u>Sign Ordinance Amendment Attorney Jansen</u> explained the proposed sign ordinance amendment. The amendment was recommended by <u>Township Planner David Banisch</u> to the Washington Township Planning Board in a May 9, 2015 memo.
