The meeting was opened to the public for items not on the agenda. There were no questions or comments from the public and the meeting was closed to the public.

PUBLIC HEARING/APPLICATIONS -

 <u>Dr. Anthony Iuvone</u> – Block 2, Lot 6 – Route 46 – C-1 Zone - .544 Acres Preliminary & Final Site Plan Application for a Dental Office Completeness Determination and possible Public Hearing Representatives present: Attorney Michael Selvaggi, Dr. Anthony Iuvone, Dr. Ben Iuvone

The applicant's attorney Michael Selvaggi from the law firm of Courter, Kobert and Cohen introduced the proposed project. He stated that Dr. Iuvone is hoping to move his dental practice from Panther Valley to Washington Township. Attorney Selvaggi stated that the applicant is asking for a temporary for the payment of taxes. He stated that \$14,000 is currently owed by the property owner. He said that his client is asking that the payment of taxes be made a condition of approval. He stated that the taxes will be paid 30 days after the resolution of approval is adopted by the Planning Board. Mr. Selvaggi said that the seller is refusing legal counsel on the matter. He noted that the Municipal Land Use Law does not specifically address this issue.

Mr. Selvaggi stated that the applicant has had contact with the Hackettstown Municipal Utility Authority and has been instructed that in order to receive a commitment letter a formal application is needed. It was noted that a letter dated October 5, 2012 had been received from the Health Department Health Officer. Mr. Selvaggi stated that the site plans and application documents had been forwarded to the Fire Chief in August; however, no response has been received.

It was noted that a review letter has been received from the Board Geotechnical Consultant Dr. Issa Oweis. Mr. Selvaggi stated that Dr. Oweis is on vacation and unable to be at this meeting. He stated that Dr. Oweis' letter addresses the need for the proposed infiltration basin to be moved on the plan and that this may result in a reconfiguration of the parking area.

Attorney Selvaggi informed the Board that this matter has been noticed to the public and that he is requesting that the Board deem the application complete and carry the public hearing to the October 24th Planning Board meeting.

Engineer Hall stated that Attorney Selvaggi had touched on all of his completeness items noted in his October 2, 2012 letter. He said that the issue of the tax payment waiver is unique and if the Board grants it there should be a specific time period given for the taxes to be paid. Chairman Leavens asked if the taxes could be kept in an escrow for payment. Attorney Cofoni stated that she had never seen it handled that way but that she agreed with Engineer Hall about the required time limit for tax payment.
