Dennis Colditz – Part-time Senior Citizen Driver, on a 90 day probationary period, with no health benefits, pending satisfactory background check, at a rate of \$12.00 per hour, effective July 16, 2013.

Nina DiGregorio – Deputy Clerk, Deputy Registrar, at a rate of \$41,283 per annum, retroactive from January 1 thru July 1, 2013.
