The Regular Meeting of the Township Committee of the Township of Washington was called to order by Mayor Short at 7:31 P.M.

Adequate notice of this meeting was sent to the Observer Tribune and the Daily Record on January 9, 2012 and was posted on the bulletin board in the Municipal Building on the same date. This meeting is being held at the Washington Township Municipal Building, 43 Schooley's Mountain Road, Long Valley, New Jersey. Notices of this meeting were sent as there were requests.

<u>PLEDGE OF ALLEGIANCE</u> – The Pledge of Allegiance was recited.

<u>MAYOR'S UPDATE</u> – Mayor Short stated that the efforts of the Mayors of the five municipalities to consider educational system reorganization have reached an impasse. A meeting will be scheduled in September to ascertain whether these discussions will continue.

Mayor Short stated that a resolution of the collective bargaining agreement with the Township's police officers has been reached through arbitration. There will be a five year contract approved later this evening.

Municipal road repairs for 2012 are almost complete.

An Office of Emergency Management (OEM) drill took place this past week at Schooley's Mountain Park in which our Citizens Emergency Response Team (CERT) and Scouts participated. This "staged disaster" was handled very well and the results are published on Patch and in several newspapers. The CERT volunteers are now fully certified

The Township's Wastewater Management Plan which has been in the works for almost 6 years has received final approval.

A fireworks display, sponsored by the Community Events Organization, will be held on August 25th at the Middle School.

A power outage occurred this past weekend which affected approximately 1,300 homes. JCP&L has indicated to Mayor Short that the outage was due to downed trees.

An "armed individual" situation on Turtleback Road was diffused by members of our Police Department. Mayor Short commended the five offices that responded to the scene for their outstanding efforts.

Washington Township's 275th Anniversary is next year and Mayor Short will be having a meeting on September 12th with the Historical Society and various groups to start preparing for next year's activities.

<u>EAGLE SCOUT PROJECT RECOGNITION</u> - <u>Scout Nicholas Clark Hamilton</u> was recognized by the Township for achieving the rank of Eagle Scout. Mayor Short commended him for his efforts.

CORRESPONDENCE NOTED FOR THE RECORD

The 2013 Municipal Alliance allocation is \$13,103.00 contingent upon receipt of a formal letter from the Governor's Council on Alcoholism and Drug Abuse.

An on-site review of the Senior Center was conducted on July 19, 2012 in compliance with the Community Development Block Grant Program funding requirements.

DISCUSSION

MOTOR POOL BUDGET UPDATE - Mayor Short stated that repairs on our vehicles are higher than expected because the vehicles are getting older. Scott Frech, DPW Superintendent, requested that additional funding toward the motorpool budget be considered for 2013. Comm. Tobin stated that he will bring this issue up at the Fire Chiefs meeting tomorrow evening. He stated that the Township should consider if it wants to cover repairs/maintenance on both Chiefs' and Assistant Chiefs' vehicles. The Township has looked at the breakdown of the cost of its municipal fleet with respect to maintenance, repairs, age, mileage, etc. These costs will continue to be investigated.

ROAD CONSTRUCTION FIRM – Comm. Tobin stated that the road construction firm that the Township used this past year has been outstanding. He feels that the signage was excellent and that the work progressed in a timely

<u>GREEN MARKET</u> – <u>Comm. Tobin</u> stated that the **Secretary of Agriculture Fisher** and a representative from the USDA visited our Green Market. It was one of three in the state that they have attended in a week long promotion of Green Markets in New Jersey. They were there for an hour and spoke to all of the vendors and the public to show their support of these markets.

<u>MUA</u> – <u>Mayor Short</u> stated that he met with the MUA regarding several projects. The water pumping station is going out to bid in September and a test well on top of the mountain currently has a good yield. Combe Fill South has been shown to have more contaminants. Washington Township MUA will be supplying water to the affected areas in our Township and in Chester. A public meeting will be held in mid September to discuss the hookup, which will be at no cost to our residents. The Environmental Protection Agency (EPA) and the Department of Environmental Protection (DEP) will be funding the project.
