#### MAYORS UPDATE

Monday, March 25 at 5:30 PM, **Congressman Lance** will be coming to the Municipal Building for a Town Hall Meeting.

**Mayor Short** will be meeting with JCP&L representatives on Thursday March 21; to tour staging areas in the Township should they be needed in another weather emergency situation and discuss circuit maps. JCP&L will also be presenting a check to the municipality for \$1,000 in recognition of the Township's 275<sup>th</sup> anniversary.

#### **PRESENTATION**

<u>Community Garden.</u> The garden concept has been discussed for two years, and it was decided that there is an interest and need for a Community Garden in Washington Township. The volunteer group received a \$1,000 grant from the NJ Garden Club, and \$800 from the State of NJ to be used for materials. **Attorney Jansen** recommended the Township adopt an ordinance to specify fees, authorize the use, establish rules and regulations, and recognize the volunteer committee as the Township's agent.

<u>Denise Tedeshi</u> a member of the Washington Township Community Garden Committee stated the Community Garden website will have a downloadable application. When the ordinance is adopted that information will be included on the website also. The application will also appear on the Township website. Community Garden fees will be used to purchase lumber for raised beds, and eventually a shed.

#### **ORDINANCE DISCUSSION**

<u>MUA Conservation Easement.</u> Mike Pucilowski, Director of the Washington Township MUA, discussed the need to amend the conservation easement at 46 East Mill Road, to allow for water supply improvements within the conservation easement. The Planning Board has recommended approval. Mayor Short and Committeeman Tobin own property close to the property in question and therefore there is no quorum to act on the ordinance at this meeting. This topic will be addressed at the March 25, 2013 special meeting.

<u>Taxi Limousine Ordinance</u>. The original ordinance was adopted in 1997 and revisions are now necessary to comply with changes in state statutes. The Township Committee agreed that the ordinance will state that the maximum number of taxi cabs will be 5 and the maximum number of limousines will be 5.
